CIMIC Group company CPB Contractors has been awarded a package of gas gathering and infrastructure works worth approximately \$90 million for Australia Pacific LNG (APLNG) in the Surat Basin, Queensland.

The contract, which will deliver more than 300 coal seam gas wells over two years, consolidates CPB Contractors' position as a key delivery partner in the provision of gas infrastructure in Queensland.

CPB Contractors has delivered gas gathering infrastructure for more than 800 wells for APLNG over the past five years.
